This is a summary of the annual report of the NEW TSI HOLDINGS, INC. EMPLOYEE BENEFITS PLAN, EIN 85-3482599, Plan No. 502, for period 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

NEW TSI HOLDINGS, INC. has committed itself to pay certain self-funded Medical claims incurred under the terms of the plan.

Insurance Information

The plan has contracts with THE GUARDIAN LIFE INSURANCE COMPANY OF AMERICA, METROPOLITAN LIFE INSURANCE COMPANY, VISION SERVICE PLAN, AETNA LIFE INSURANCE COMPANY, SHELTERPOINT LIFE INSURANCE COMPANY to pay Dental, Vision, Life Insurance, Short-term Disability, and Accidental Death and Dismemberment claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$259,725.
